Subject: Conflict Minerals Reporting under the Dodd-Frank Act – **Report Required**

Dear Supplier:

You are receiving this notice because you are a supplier to one or more **Pursuit Aerospace** companies. These companies include Berkshire Manufactured Products, Inc; Connecticut Tool & Manufacturing Company, LLC; Eurocast SA (Tunisia); Multax LLC; Palmer Manufacturing Co., LLC; Paradigm Precision Holdings, LLC; Paradigm Manchester Inc.; Paradigm Orillia Technology Inc. (Canada); Paradigm Precision Burnley, Ltd (UK); TM Industries, LLC; Turbine Engine Components Technologies Corporation; Turbine Engine Components Technologies - Utica Corporation; Turbocombustor Technology, Inc.; Whitcraft LLC; and Whitcraft South Windsor LLC.

The Dodd-Frank Act imposed certain requirements relating to Conflict Minerals, as explained below. Specifically, a SEC rule adopted pursuant to the ACT requires publicly traded companies whose products contain tantalum, tin, tungsten, and gold (known collectively as “3TG”), to include certain information about those elements in annual reports to the SEC. The reporting requirements reflect congressional concern that revenues obtained from mining and transport of 3TG obtained from certain areas within the Democratic Republic of Congo (DRC) and surrounding countries are used to underwrite paramilitary and other activities resulting in an ongoing humanitarian crisis. 3TG materials obtained from these areas are known as “Conflict Minerals.”

The rule requires companies to conduct a “reasonable country of origin” inquiry to determine whether Conflict Minerals used in products they manufacture or contract to manufacture originated in the DRC or an adjoining country or came from scrap or recycled sources. If any Conflict Minerals (1) originated or may have originated in the DRC or an adjoining country and (2) did not come, or may not have come, from scrap or recycled sources, companies will have to conduct additional supply chain due diligence and determine whether those Conflict Minerals are “DRC conflict free” (that is, they did not directly or indirectly finance or benefit armed groups in those countries). We are collecting information on Conflict Minerals to comply with the provisions of the Dodd-Frank Act. This is being done through the use of the Template, which we have made available through our website or by email to our direct suppliers. The Reporting Template provides a common industry approach for the collection of sourcing information related to conflict minerals. As a supplier, you may have previously provided similar reports to other customers of your company.
